Our comment We object to this application based on the lack of parking provision, the

detrimental impact the on-street parking will have on access for vehicles

(Emergency vehicles, refuse vehicles etc) and on the negative impact on the street scene from the loss of the front garden. With regard to the parking – we note the prohibition of waiting order proposed for Halls Lane and Westlands Avenue, and the impact of application F/2014/1307 on existing parking problems in this area – we draw the planning officer's attention to the likelihood of similar issues being created on the Shinfield Park development if additional HMO permissions are

granted.

Proposal	Proposed change of use and conversion of 1no residential dwelling (use Class C3) into a house of multiple occupation (Use Class Sui Generis)
Our comment	The parish council feels that it is inappropriate to base the parking provision for this application on Reading's standard for HMOs. Additionally, in WBCs current parking standards, a garage is only considered to be half a parking space, where this is referencing the double garage as two usable spaces. The parish council urges the highways department to review the parking situation on this development, particularly in light of the number of vehicles that park on the road and on verges, causing concern over access for refuse and emergency vehicles.
